*Glasgow Legal Theory (GLT) was formally set up as a research group in May 2016. Current membership includes Emilios Christodoulidis, Ruth Dukes, Lindsay Farmer, Marco Goldoni, Lilian Moncrieff and George Pavlakos. We have been joined this year by Anna Chadwick, research fellow in the Glasgow School of Law.*

*The activities of the group are driven by the shared research interests in a number of different substantive fields – criminal law, public law, labour law, corporate governance, EU and international law – with a special emphasis on the philosophical foundations of the law, and the development and application of critical perspectives. In recent years the work has focused on questions of law and political economy, crime and responsibility, national, transnational and international legal orders, and on different aspects of constitutionalism: constitutional theory; constituent power; conceptual issues around constitutionalism; the labour constitution and the constitution(s) of the EU.*

### NEWS

- **ERC funding for a project on the 'economic sociology of labour law'**

Ruth Dukes has received a major funding award of € 1.4 million from the European Research Council (ERC) for a project on 'Work on Demand: Contracting for Work in a Changing Economy'. She will seek to investigate the ever-evolving nature of contracts and contracting behaviour in the world of work – not only contracts of employment, but also those of casual, 'zero-hours', and self-employed workers.

A particular point of focus is the emerging 'gig' or 'on demand' economy, in which consumers order a range of services, or delivery of a range of goods, online or via smart phone apps.

The project is motivated by a normative and empirical concern with the continued viability of systems of labour law that are protective of workers' interests. It has a strong comparative dimension, and will analyse differences in forms of contract and contracting behaviour across jurisdictions and over the course of several decades. With the aim of developing a new methodology for the study of work contracts, it will seek to synthesise elements of economic sociology, sociology of law, and political economy into a new 'economic sociology of labour law'.

Ruth plans to recruit 4 doctoral students and two post-doctoral fellows, commencing in summer/autumn 2018.

Wolfgang Streeck, 'GLT fellow' for 2018 will give the 3<sup>rd</sup> Adam Smith Lecture in May 2018.


