

### • Food Sovereignty Research Network

Donald Buglass (Law), Dr Anna Chadwick (law), Dr Sourit Battacharya (Postcolonial studies) and Dr Julia McClure (History) launched the *Food Sovereignty Research Network* in the Spring this year. The network takes an interdisciplinary approach and focuses on how ideas and practices of history, power, and justice are integral to food production and cultures of food consumption.

On June 30th the network hosted its first knowledge exchange event with local organisations engaged in improving access to urban growing space and the affordability of nutritious food for Glasgow residents.

The network has two artists in residence, filmmaker Zev Robinson and animator Trasi Henan, and is working with curator Tomasso Ranfagni to produce an online exhibition about food sovereignty and radical growing practices in the run up to the COP<sub>2</sub>6.


### Glasgow Legal Theory Reading Group


We are delighted to be welcoming back Scott Veitch (HKU) as a visitor for this academic year.

#### Publication of 'The Redress of Law'

We are pleased to announce the publication of Emilios Christodoulidis's book 'The Redress of Law: Globalisation, Constitutionalism and Market Capture'.

'From a legal-philosophical point of view, The Redress of Law presents a critical analysis of a number of related doctrinal fields: constitutional, labour and EU Law. Focusing on the organisation and protection of work, this book asks what it means to protect work as an essential aspect of human (individual and collective) flourishing. This restatement of critical legal theory is intended to defend the concept of constitutionalism and suggest new ways to deploy the law strategically.'

#### • Law and Utopia

We will be hosting a workshop on the theme of 'Law and Utopia' in Glasgow in early December with the participation of Johan van der walt (Luxembourg), Neil Walker (Edinburgh), Andreas Takis (Thessaloniki) amongst others. This event is part of the project 'Utopias' in collaboration with the University of Thessaloniki and the city's museum of Modern Art (MOMus).

## • The Rule of Law and Private Power Seminar Series

The series, which will run from September to December 2021, will be focused on answering questions such as: How does law generate private power? Through which prohibitions or permissions does the (international) legal infrastructure create and sustain asymmetries of power that result in socio-economic inequalities? Do globalisation and the emergence of global private powers entail a paradigm shift with regards to both the origins and the possibilities to restrain private power?

Going beyond a conceptualisation that limits the scope of the rule of law to the state and its exercise of public power, the webinar series explores the relevance of the rule of law framework for the exercise of private power – particularly targeting transnational actors.
