We were pleased to welcome Sally Zhu to the GLT team in November 2018, joining us as a Leverhulme Trust Early Career Researcher. Sally was awarded her PhD from LSE in 2018 and previously studied at the University of Cambridge (LLM) and LSE (LLB). Her project investigates how cyber- and sharing-economies change the material relations between persons and objects, and what implications these have for the fundamental concepts of property. At present her focus is on how activities in the sharing economy can produce different assemblages of labour and property, to reconceptualise relations between persons mediated by material objects.

8th Annual Lecture in Jurisprudence

On Friday 19 October 2018 we hosted the 8th Annual [Jurisprudence](#) Lecture given by Alain Supiot. Professor Supiot holds the Chair ‘Etat social et mondialisation : analyse juridique des solidarités’ at the Collège de France. He is the Founder, and currently Fellow, of the Nantes Institute for Advanced Study (IEA), Fellow of the British Academy, and a member of the International Labour Organisation’s Global Commission on the Future of Work. His lecture, titled “Democracy laid low by the market” offered a defence of the value of democracy as a source of meaning and guarantee of the trustworthiness not only of our shared political institutions but also of the spoken word itself. The lecture was published in the latest issue of the journal *Jurisprudence*.




